SECTION 17.5 OGDENSBURG MUNICIPAL CODE

“An application for a license as a solicitor who demands, accepts or receives payment or deposit of money in advance of final delivery shall also be accompanied by a cash deposit of five thousand dollars (\$5,000), or a five thousand dollar (\$5,000) surety company bond or other bond secured by sufficient collateral, said bond to be approved by the City Attorney as to form and surety conditional for making a final delivery of goods, wares, or merchandise ordered, or services to be performed in accordance with the terms of such order or failing therein, that the advance payment on such order be refunded. Any person aggrieved by the action of any licensed solicitor shall have the right by action on the bond for the recovery of money or damages, or both. Such bond shall remain in full force and effect and, in the case of a cash deposit, such deposit shall be retained by the City for a period of ninety (90) days after the expiration of any such license, unless sooner released by the City Council.”

All applications for a Peddler’s License shall be accompanied by an endorsement, in writing of two reputable citizens of the State of New York certifying to the good reputation of the applicant.

If applicable, such application shall be accompanied by a certificate from the Sealer of Weights and Measures certifying that all weighting and measuring devices to be used by the applicant have been examined and approved.
