License shall be renewed July 1<sup>st</sup> of each year. No license fee shall be charged to an owner who exclusively drives his own taxicab. Owners who drive their own taxicabs shall, however, be required to obtain a drivers license as provided herein except that same shall be issued without cost upon payment of the license fee of their vehicles.

This application must be returned to the City Clerk's Office with the \$25.00 non-refundable fee for processing.

**APPLICANTS:**

Your application may be rejected for failure to disclose fully the information requested on the application (alcohol related driving offenses, other serious Vehicle & Traffic Law violations and certain Penal Law violations). Listed below are some examples of arrests/convictions that may result in disapproval:

- (1) alcohol related Vehicle & Traffic offenses;
- (2) driver's license or registration suspension;
- (3) excessive speed convictions;
- (4) misdemeanor Vehicle & Traffic convictions (Reckless Driving, drag racing, etc.);
- (5) Penal Law arrests/convictions for: larcenies, assaults/violent crimes, robbery.

These examples are for illustration only, and rejection of your application is **not** limited to the violations noted.
