3. Councillor Powers stated that he went to many City parks this summer with his children and would like to bring the resolution prohibiting smoking in City parks back to the Council table.

Mayor Nelson asked Council to give their feedback to Justin Woods, Director of Planning and Development. Mayor Nelson also asked the City Manager to post the smoking survey results on the City website.

Councillor Morley requested Council be given a copy of the survey of it will be discussed at a meeting.

NEW BUSINESS

- 1. Mayor Nelson read a proclamation for the week of October 19-25, 2008, as "Friends of the Library Week in Ogdensburg, New York, St. Lawrence County", and urged citizens to join the Friends of the Library and thank them for all they do to improve our library and community. (A copy follows these minutes.)
- 2. Mayor Nelson stated that Dr. David Franz is retiring as Director of the Library and thanked him for his years of dedic ated service and a job well done.
- 3. Councillor Hannan requested that Mrs. LaMacchia's suggestion to put mesh or wiring beneath the Spring Street Bridge to prevent rocks from being thrown off the bridge, be turned over to staff for recommendation. Councillor Hannan also questioned if a citizen survey should be conducted related to juveniles in the community. Mayor Nelson stated in our recent citizen survey questions 18 through 25 related to safe walking in the City at night.

City Manager Arthur Sciorra stated that he will have further discussions with Police Chief Rick Polniak on this topic.

Councillor Powers suggested a Neighborhood Watch Program.

Police Chief Rick Polniak stated that juveniles were identified in this incident as possible suspects, but there are certain conditions to interview juveniles and this case will go through Family Court.

Councillor Hannan questioned the condition of the barriers that stop vehicles on the trail walkway. Mr. Sciorra stated that the ballards need to be replaced.

On a motion duly made and seconded, the meeting was adjourned.
